Design and Consultation

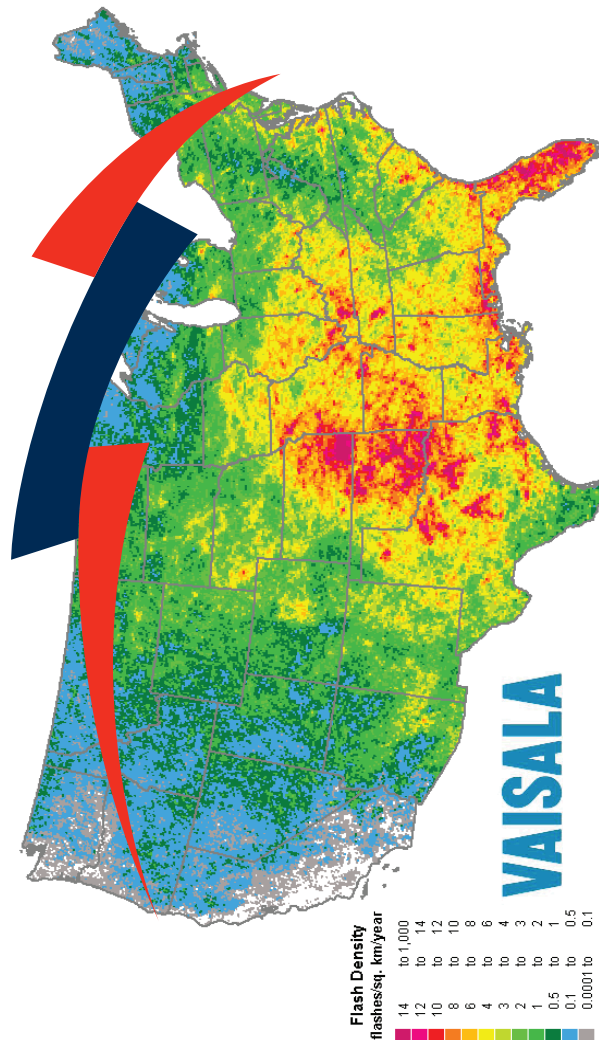

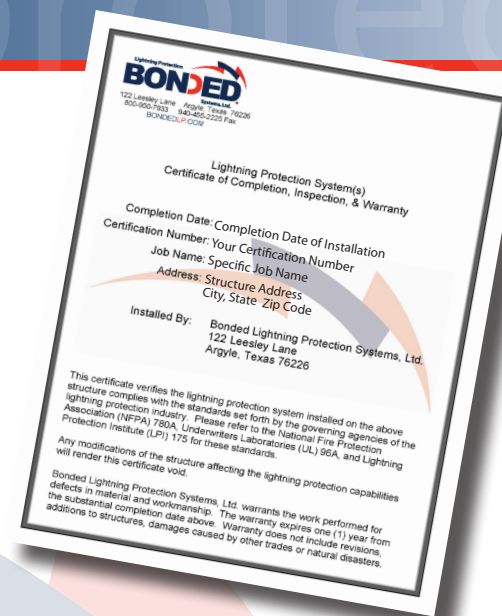


The Proven System
